



Cannabis Europe

Cannabis has been an integral part of medicine for centuries. However, Western countries have come to prohibit or limit cannabis use. Yet, as the medical use of cannabis gains ground, **European regulation needs to develop in order to support the needs of patients for access to safe, high-quality cannabis-derived medicines.**

Europe is forecasted to become a leading market for medical cannabis, with a market value of around €55.2bn over the next 10 years¹. As therapeutic applications are developing, patients and public policy knowledge remain incomplete or flawed, owing to societal misperception and deep-rooted beliefs.

Cannabis Europe is a patient-driven advocacy group, comprising scientific organisations, academia, patient organisations, NGOs and industry, **which aims to ensure patient access to high quality, safe, cannabis-derived medicine** and demonstrate the benefits it brings to patients towards European policy-makers.

The regulatory framework around cannabis use in medical applications is currently fragmented across European Member States. In this regard, **Cannabis Europe** fosters an open and transparent dialogue with policy-makers and society with a view to harmonising the use of cannabis-derived medicines throughout Europe.

Cannabis Europe's mission is threefold:

1. To ensure European patients have fair access to consistent, high-quality, cannabis-derived medicines;
2. To engage all European stakeholders, including patients, in discussions pertaining to medical cannabis and its use; and
3. To promote a better understanding of the medical uses of cannabis through clear, science-based and transparent information.

Cannabis Europe's core activities

Cannabis Europe organises and undertakes the following activities in order to achieve an EU-wide harmonised legislative framework:

1) Education & Communication:

- We produce and publish information on medical cannabis and its uses.
- We promote and aim to increase the stakeholders' understanding of the use of cannabis in medical applications.

2) Advocacy:

- We undertake public affairs activities, e.g. representing and sustaining a dialogue with institutions and regulatory bodies at European, international and national levels.
- We assist national associations and members in building long-lasting networks with the European Commission, Members of the European Parliament and national government officials.

Cannabis Europe's Member services:

1. Provides opportunities for members across Europe to meet, exchange information and ideas and discuss current issues and upcoming challenges regarding the development of medical applications of cannabis.
2. Provides regular updates on regulatory and policy developments and events through e.g. monthly newsletters, as well as instant updates on key developments.
3. Advises members on opportunities in the area of EU-funded projects and help them identify potential research partners and opportunities in the framework of Horizon Europe, the future EU research and innovation programme, which should include calls for project proposals for developing medical cannabis applications.
